On December 30, 2008, Conestoga-Rovers & Associates (CRA) submitted a report entitled "Data Report, October/November 2008 Residential Well Sampling Event" (Report) to the Minnesota Pollution Control Agency (MPCA) on behalf of Reynolds Metals Company and Whirlpool Corporation, the Responsible Parties at the Highway 96 Dump Superfund Site.

The Report is hereby approved, pending the clarification of one item. The Report indicates that 62 locations were sampled, but MPCA records indicate 61 addresses were sampled. Table 1 lists 5 West Shore Road as having been sampled twice. Therefore we request that CRA review its information and clarify the number of homes/addresses that were sampled during this event.
