RESOLUTION DESIGNATING POLLING LOCATIONS FOR THE 2023 SCHOOL BOARD ELECTION

WHEREAS, Minnesota Statutes 204B.16, Subd. 1 requires the City Council, by ordinance or resolution, to designate polling places for the upcoming year; and

WHEREAS, changes to the polling places locations may be made at least 90 days before the next election if one or more of the authorized polling places becomes unavailable for use; and

WHEREAS, the School Board Election is November 7, 2023.

NOW, THEREFORE, BE IT RESOLVED, the North Oaks City Council hereby designates the following polling places for elections conducted in the city in 2023:

- Precinct 1 City of North Oaks 100 Village Center Drive, Suite 150
- Precinct 2 August 8th Primary: North Oaks Council Chambers 100 Village Center Drive, Suite 150 November General Election: North Oaks Golf Club 54 East Oaks Road, North Oaks

AND BE IT FURTHER RESOLVED, that the city clerk is hereby authorized to designate a replacement meeting the requirements of the Minnesota Election Law for any polling place designated in this Resolution that becomes unavailable for use by the City;

AND BE IT FURTHER RESOLVED, that the city clerk is directed to send a copy of this resolution to the Ramsey County Elections Office.

North Oaks Truth in Taxation Meeting Minutes North Oaks City Council Chambers December 8, 2022

CALL TO ORDER

Mayor Ries called the meeting to order at 6:45 p.m.

ROLL CALL

Present: Mayor Kara Ries. Council Members Rich Dujmovic, Jim Hara, Sara Shah, Tom Watson. Staff Present: Administrator Kevin Kress, Attorney Jim Thomson, Engineer Tim Korby. Others Present: Videographer Kenny Ronnan A quorum was declared present.

APPROVAL OF AGENDA

Motion by Watson, seconded by Shah, to approve the agenda. Motion carried unanimously.

DISCUSSION ITEMS

1. Truth-in-Taxation Hearing 2023 Budget/Levy

Administrator Kress noted one error found in the budget that has been corrected. The correction dropped the tax rate down to about 11.53% and will save residents an additional \$20-\$40. He noted 11.53% is one of the lowest tax rates in the last 10 years for a total levy of \$2,182,645.

2. Discussion and possible action on 2023 Budget/Levy

Mayor Ries thanked Member Hara and Staff for all their work on the budget over the last few months.

Member Hara hopes the new City Council can resolve the police contract and either receive services they pay for with an additional person or the extra fee is taken off by the Sherriff's Department.

Member Watson stated compensation increases for personnel is shown about 5%. Regarding the Sherriff contract and Lake Johanna Fire, Member Watson is not pleased about either of them. The Sherriff's increase is 8.2% and the City has never had the opportunity to truly negotiate that. Regarding Lake Johanna Fire, that budget is 8.7% and although Member Watson gave his economic inflation speech, the budget passed 5-2 with one fireman joining Member Watson's vote. He noted if they continue to spend money at the rate of inflation they are compounding the problem and not solving it. Member Watson spoke about the Building Official budget, noting that person gets a percentage of whatever fees are and the contract did not change. The only thing that will generate more revenue for the Building Official is if the City changes the fee

schedule. Member Watson appreciates that the City is approving a levy that is one of the lower increases in several years.

Mayor Ries mentioned they will reserve the vote on the budget/levy for the City Council meeting. Administrator Kress noted the Resolution with the updated levy number was complete, if council wished to close out the agenda item and there was no further discussion.

MOTION by Watson, seconded by Hara, to approve Resolution #1470 with a levy of \$2,182,645. Motion carried unanimously.

ADJOURNMENT

Mayor Ries adjourned the meeting at 6:59 p.m. Motion carried unanimously.

1. CALL TO ORDER

Mayor Ries called the meeting to order at 7:00 p.m.

2. ROLL CALL

Present: Mayor Kara Ries. Council Members Rich Dujmovic, Jim Hara, Sara Shah, Tom Watson. Staff Present: Administrator Kevin Kress, Attorney Jim Thomson, Engineer Tim Korby Others Present: Videographer Kenny Ronnan A quorum was declared present.

3. PLEDGE OF ALLEGIANCE

Mayor Ries led the Council in the Pledge of Allegiance.

4. CITIZEN COMMENTS

Lisa Dujmovic, 15 Black Lake Road, thanked the City Council Members for their service to the community. She noted Member Watson's history and knowledge are irreplaceable and said Member Hara has done great and given so much time and business talents for many committees. Ms. Dujmovic thinks Mayor Ries embodies what every coach looks for in their players; she gives all that she has to everything and leaves it all on the court. She cannot think of anyone who has tried harder than Mayor Ries to keep the City a premier landing place for people and she has done amazing work. Ms. Dujmovic believes the three Members who are leaving are some of the heroes of the story within the City. Heroes have to deal with obstacles, mischaracterizations, and low-blows, but in the end the story always works out. To Ms. Dujmovic's personal hero Member Dujmovic, he is a man of character and integrity. When a letter was circulated at the eleventh hour before the election which did not get his voting record correct and implied he had a personality that anyone watching the meetings would realize is completely false. When she asked if she should circulate an email to let people know, he said it was okay and that he only cared what Ms. Dujmovic thought of him, and if God wanted him to win he would; if not, he would move on. Ms. Dujmovic stated she is proud that he lives in such a way as to please his maker, he is an ordinary guy who is an extraordinary leader and she is very proud to be his wife and best friend. She thanked the City Council.

5. APPROVAL OF AGENDA

Mayor Ries noted they will remove item 6e which has been resolved. She would like to add an item under New Business regarding a contract for staff member Stephanie Marty.

MOTION by Watson, seconded by Hara, to approve the Agenda as amended.

Shah is concerned without input documents to review regarding the added item under New Business. She asked if they can receive more information about this.

Mayor Ries asked to add it to the agenda and then they will talk about next steps and how to address it.

Shah noted they usually move items to a Closed Session when discussing staff and asked if this is appropriate.

Attorney Thomson replied based on the wording of the agenda item he cannot think of anything that is not appropriate.

Motion carried as Members Dujmovic, Hara, Ries, and Watson voted for; Member Shah voted against.

MOTION by Watson, seconded by Dujmovic, to approve the Consent Agenda. Motion carried unanimously by roll call.

<u>7. PETITIONS, REQUESTS & COMMUNICATIONS</u> a. Deputy Matt Lassegard Report

Deputy Lassegard introduced himself, noting he has been doing tours of the City, and he understands the importance of safety on the trails and dispatching law enforcement and fire department as first responders. He spoke about three car accidents on the periphery of the City.

Mayor Ries noted road and traffic safety is extremely important in North Oaks.

8. UNFINISHED BUSINESS

9. NEW BUSINESS

a. Contract with City Clerk Staff member

Mayor Ries noted the Staff member who does the Accounting and City Clerk position, Stephanie Marty, has been with the City for 20 years. She has extensive knowledge, has been a valuable asset to the City, and Mayor Ries thinks it is a good idea to reward Staff members that have shown two decades of service with a contract of employment. Mayor Ries proposes to draft a contract with the City versus what they currently have regarding the role. She noted this would be a basic employment agreement contract with similar terms to what Administrator Kress has.

Member Watson was part of the team that hired Ms. Marty and would be in favor of the contract. He does not think this would do any more than memorialize the arrangement the City has with Ms. Marty and would provide a degree of comfort and a bit more security. He thinks it is good protection for the City.

Member Shah asked if they have a City handbook and whether the City Administrator makes the recommendation or the City Council.

Attorney Thomson clarified the position reports to the City Administrator but the City Council hires, fires, and retains employees. If the Council wants to have a contract with an employee they have the authority to do so.

Member Shah would like to see some of the input documents and contract.

Watson suggested putting a draft together and circulating the document for review and discussion of terms.

MOTION by Watson, seconded by Hara, to direct Staff to prepare a draft agreement and direct Member Hara, Administrator Kress, and Attorney Thomson to bring it back to the City Council. Motion carried as Members Dujmovic, Hara, Ries, and Watson voted for; Member Shah voted against.

The Commissioners discussed the Cost of Living Adjustments (COLA) for full time and part time employees.

MOTION by Watson, seconded by Hara, to increase full staff by 5.5%, and part time staff by 7% for 2023. Motion pass unanimously.

Administrator Kress noted he didn't have a need to conduct a formal annual performance review to gain feedback. He asked councilors to provide any additional feedback to him at any time.

10. COUNCIL MEMBER REPORTS

Member Hara gave an update on the NRC meeting, noting it could be a quarterly (rather than monthly) meeting. He thanked the City Council and Staff and said being on the Council has been a big learning experience for him. He wishes the new Council the best of luck.

Member Watson stated there are vacancies on the NRC and they must be residents of North Oaks. Regarding White Bear Lake and water, a group met and went through nine talking points;

they will put together a further document. He spoke about reinstating the JPA, withdrawing the cancellation notice, and putting performance indicators into the JPA. They also need to figure out if there is a role for Vadnais Lakes Water Management Organization (VLAWMO) in the groundwater business. Member Watson spoke about managing trees in Red Forest and noted Forester Mark Rehder is putting together a draft for the City with technical wisdom on managing hardwood forests. Member Watson will miss Member Dujmovic at the City Council table, he is a man of great integrity, and Mr. Watson respects that Member Dujmovic is a team guy. Member Watson has utmost respect for Member Hara's father and noted Member Hara is a chip-off-the-old-block. It has been great getting to work with Member Hara. Member Watson spoke about Mayor Ries noting she has worked extremely hard and most that know her have a great deal of respect for that work. He thinks her integrity is wonderful and she does not have to apologize for anything. He appreciates getting to know Mayor Ries.

Member Dujmovic shared that Jim McGillis hosted his final North Oaks Home Owners' Association (NOHOA) Safe Communities, Safe Roads Committee meeting and he is grateful for Mr. McGillis' leadership. NOHOA will require additional feedback on speed mitigation before they would like the City to progress with mitigation. Member Dujmovic thanked Deputy Lee, Deputy Burrell, and Deputy Lassegard for their service to the City. He thanked Staff for their help noting they are a pleasure to work with. Member Dujmovic stated Mayor Ries was kind from the first moment they met, and has given her time in listening and understanding which meant a lot. Member Dujmovic thanked Member Watson who rose to the occasion and came through when the community needed him and noted he exemplifies service. Member Dujmovic noted everything Member Hara touches is done exceptionally well, and he brought tremendous business sense and wisdom. Member Dujmovic thanked Member Shah for the way she cares, is dedicated, and has passion to see the right thing done. He thanked his wife Lisa, and wished good luck to the incoming Council.

Member Shah thanked Members Hara, Watson, and Ries as their terms come to an end. She appreciates all their time and efforts in serving the community.

Mayor Ries thanked everyone for the opportunity to serve the community, it is a wonderful community filled with amazing volunteers and well-educated people. She spoke at a Rotary Club meeting recently about service with gratitude and she is grateful to have gotten to know many people, to work on issues and contracts, and to work with surrounding communities. She thanked Member Watson for all his hours on the phone, and stated he is a huge asset to the community. Mayor Ries noted Member Hara's mind is amazing with numbers and the City is in a great spot because of his accounting, brilliant mind with numbers, and detail. Mayor Ries noted Member Dujmovic has integrity, honesty, intelligence, and she could go on with the level of detail noting he is one of the most professional people she has ever met. It was a pleasure working with him in this job. Mayor Ries thanked Member Shah for her dedication on the City Council, noting she is representing young mothers with young kids and it is not easy to be the minority voice on the City Council. Member Shah stood up for what she believed is right and that is something to be very proud of. She thanked the City Attorney, City Engineers, and City Staff for their work for the North Oaks. Mayor Ries noted it has been a pleasure representing the residents.

11. CITY ADMINISTRATOR REPORTS

Administrator Kress has enjoyed getting to know everyone at the table, both professionally and personally. He noted being on the City Council can be at thankless job, and is a lot of time and effort. He thanked everyone for their service.

Engineer Korby has enjoyed working with the City Council and noted they will continue to serve in many ways, even if they are not serving in that role anymore. He spoke about their collaboration regarding trees and the environment and thanked the Council for their efforts and hard work.

12. CITY ATTORNEY REPORTS

Attorney Thomson admires anyone who holds the role of City Council Member, they do an amazing amount of work and are basically volunteers. He noted this job has not been boring and he looks forward to the future. He shared a motion regarding Cherrywood was denied by the Court of Appeals and will update the City Council in January on the case.

3. CONSIDER EMPLOYMENT AGREEMENT FOR DEPUTY CLERK

- Watson inquired whether Marty has reviewed. Ries stated she has had verbal discussions and conversations with her, but doesn't believe she has yet seen the final physical copy. Attorney Thomson noted that it would be best if she could review and sign by end of day 12/31/22.
- Mayor Ries noted in order to best protect the City, it would be good to protect her institutional knowledge, value and effort she has brought to our City over the many years.
- Dujmovic agreed that she has excellent presence, knowledge and interpersonal skills.
- Watson stated there are lots of openings and turnover within Twin cities government organizations and there is value to keeping our knowledge within our City.
- Hara agreed that staff that knows ins & outs of unique City should be recognized and retained.

North Oaks City Council Special Meeting Minutes North Oaks City Council Chambers January 9, 2023

1. CALL TO ORDER

Mayor Wolter called the meeting to order at 5:00 p.m.

2. ROLL CALL

Present: Mayor Krista Wolter, Councilmembers Tom Watson, Sara Shah, John Shuman, Mark Azman

Staff Present: Administrator Kevin Kress, Attorney Jim Thomson (via zoom) A quorum was declared present.

*Any participants on Zoom had difficulty hearing, due to issue with zoom connection in Chambers. Minutes to be shared with public.

3. DISCUSSION ITEMS

3a. Discussion on 2023 annual appointment resolution

- Mayor Wolter suggested it seems relevant to review some of our key contractual commitments to the city.
- Watson noted that the many of the key contractors such as Planner, Engineer, Attorney were newly hired 2 years ago. The building official contractor was signed 18 months ago. Some of areas such as Fire and Police services have more limited options, and would take much more time to come up with alternatives.
- Administrator Kress asked for guidance on which contractors they are focused on. Consensus was Planner, Engineer and Attorney.
- Azman noted that he has been disappointed in some issues over the past 2 years, and feels it is relevant to review some of these services again.
- Shah mentioned she would also be open to reviewing some of these parties. She would like to see if Attorney Nason would be interested in working with our City again.
- Councilor Shuman agreed that it is a good idea to review key contractors.
- Administrator Kress will review before February Meeting what firms may interested in coming back to meet and make a presentation to work with North Oaks.
- Kress also asked Councilors to take a look at the Council Appointment list for various external commissions, to determine what they might be interested in serving on. Follow-up discussion to take place at the Thursday regular Council meeting.

3b. Discussion on Natural Resource Commission

• Administrator Kress stated that over the past year, the Natural Resource commission has had difficulty maintaining consistency and a clear agenda for meetings.

- Council Azman wasn't clear on their reporting structure and what their "charge" and objective is.
- Watson noted the Natural Resource Commission objectives are in the Comprehensive Plan and suggested Kevin circulate information on their objectives. He shared historical information on how the NOHOA NEST committee was created during a lull in City. He suggested it may be worth discussing since NOHOA has budget issues, perhaps NOHOA and City can work together on issues of Natural Resources. Since North Oaks is considered a wildlife refuge, want to make sure DNR stays out of it.
- Shah noted that the Natural Resource Commission is lacking clear objectives and goals from Council. If council does a strategy session, it may assist in developing goals for NRC.
- Azman felt it important to maintain the Natural Resources Commission to ensure the City maintains a presence and focus on our natural environment.
- Discussion to be tabled until after strategy session to determine if clear items for NRC to work on.

3c. Discussion on Planning Commission and appointments

- Administrator Kress noted there are 3 openings for the planning commission. There is a current policy in place for addressing openings. Kress suggested that Councilor Azman and the Mayor meet with the applicants this week, with the goal of coming back with recommendations by the regular Council meeting Thursday.
- Kress stated there are no current projects in the CUP queue right now, and current commissioners stay on until the positions are filled.
- Councilors asked for the applications from all applicants to be sent to them.
- Watson stated he'd like to be involved in the appointment of Planning Commissioners. Feels it is relevant to take look at ordinance, the cases in front of us and behind us, and get sense of the qualifications needed for it.
- Watson indicated that he is was not part of the interviews, then he might reach out to the candidates directly to chat with them. Councilor Shah and other felt this was not an appropriate precedent to set, and to let the policy of 2 member of Council conduct interviews and come back with recommendations was best course of action.
- Azman would like to review the policy and make sure it is followed exactly. Feels the Planning Commission chair should be involved in the interviews as well. In this instance, there is no Planning Commission chair as he has vacated this role to serve on Council.
- Mayor Wolter feels it is important to get the seats filled soon as possible. She would like to move forward following policy with Kress/Azman/Wolter conducting interviews.
- Administrator Kress has called to confirm that current planning commissioners are still interested in continuing. The only party he has not heard from yet was Ostlund. He will follow up prior to the Thursday Council meeting.

3d. Discussion on setting Council Strategy and Orientation session

• Mayor Wolter would like to conduct a City Council Strategy session the weekend of January 21- 22nd. Councilor Watson noted that he is busy that weekend, but can do the following. He

would prefer to leave Sunday's free of work if possible. Azman stated he would like to have all councilors present. Administrator Kress asked Councilors to send their availability to him to find an alternate date for this strategy session.

• Administrator Kress will look scheduling a joint special orientation session with PZ and City Councilors. Watson noted Pam Whitmore, formerly with League of Minnesota Cities, conducted the last orientation session. Kress suggested it be spread into two sessions to cover more material.

AGREEMENT

1. PARTIES

This agreement is made and entered into by and between the City of North Oaks, Minnesota ("Municipality") and Northeast Youth and Family Services ("NYFS").

2. RECITALS

- a. NYFS is a non-profit social service agency whose mission is to meet the unmet developmental needs of at-risk youth and families within their community environment with emphasis on providing services through collaboration and coordination with existing community resources. These services are available to youth and families residing in the northern suburbs of Ramsey County, including, but not limited to, the municipalities which are signatory to agreements which are identical to this Agreement ("participating municipalities") and students and families from Independent School Districts 621, 622, 623, 624, 282, and 832.
- b. Through this Agreement the Municipality intends to contract with NYFS to provide such services to its residents and to act as a sponsor of NYFS by providing financial support, a method to establish appropriate services to be provided and policy guidance for its activities.
- c. This Agreement shall be used as the formal agreement between NYFS and each of the participating municipalities. This Agreement is intended to continue the spirit of cooperation and collaboration in the provision of social services between the Municipality and NYFS.

3. TERMS AND CONDITIONS

In consideration of the mutual understandings of this Agreement, the parties hereby agree as follows:

- a. <u>Prior Agreements Cancelled</u>. By execution of this Agreement any prior agreements and amendments thereto between the parties are hereby cancelled.
- <u>Services Provided</u>. NYFS shall provide the Municipality and its residents with youth and family programs set forth in the Addendum attached hereto.
- c. <u>Principles of Service and Program Establishment and Operations</u>. On a yearly basis and prior to submission of its annual budget, as provided for hereafter, NYFS shall:

- i. Report regarding proposed changes in services and programs to the Municipality; and
- ii. Establish a fair and open bidding/request for proposal (RFP) process to contract, manage or provide such services and programs, which are not directly provided by NYFS staff.

d. Funding

- i. In addition to the participating municipalities' share of the annual budget, funds for the operation of NYFS will be raised by NYFS endeavoring to secure user fees, grants and appropriations from private organizations, the State of Minnesota, Federal and County agencies, and other legal and appropriate sources.
- ii. The Municipality shall pay annually to NYFS the base amount listed in Exhibit A. This base amount will be adjusted annually for inflation/deflation based on the Standard Metropolitan Statistical Area Consumer Price Index for All Urban Consumers (CPI-U) and municipal population estimates based on MN State Demographic Center. Any adjustment in the payment beyond those indicated by reference to the CPI-U shall require approval of each of the participating municipalities.
- iii. Any new municipality joining into this agreement will pay a base amount annually to NYFS that is on par with the amount paid by current participating municipalities.
- iv. Amounts payable by the Municipality shall be paid to NYFS on or before January 30th of each year, or at a date mutually agreed upon by both parties, to cover the Municipality's share for that year.
- e. <u>Board Representation.</u> The Municipality shall have the right to NYFS Board Representation of City Council, staff or community members (as designated by the Municipality and approved by NYFS Board) on the Board of Directors as either a Board Member or Board Advisor.
- f. <u>Further Obligations of NYFS</u>. In addition to the obligations set forth elsewhere in this Agreement, this Agreement is further contingent upon NYFS doing the follows:
 - i. The Bylaws of NYFS shall be amended to add provisions requiring an open process for contracting services as provided for in paragraph C.2., above, and prohibiting NYFS from supporting or opposing individual candidates for election to public office in any of

the participating municipalities; and adding the requirement that IRS 501.C3 status be maintained.

- ii. On or before June 30, of any year NYFS shall submit the proposed city budgeted amount for the subsequent year.
- iii. On or before November 30, of any year NYFS shall submit a written report to the Municipality including an Annual Report, the audited financial statement, and a program specific summary of services provided to the municipality; in addition, 30 days from the end of each calendar quarter, NYFS shall submit a written report to the participating municipality.
- iv. Periodically advising the Municipality of services available through NYFS to the Municipality's residents;
- v. Establishing a sliding scale for services available through NYFS to the Municipality's residents and periodically advising the Municipality of such fees;
- vi. Providing other reasonable information requested by the Municipality;
- vii. Purchasing a policy of liability insurance in the amount of at least \$1,500,000.00, naming the Municipality as an additional insured and providing a copy of the insurance certificate evidencing such policy to the Municipality;
- viii. Provide the Municipality with a copy of its Articles of Incorporation, Bylaws, Amendments thereto, and the IRS tax exempt status letter;
- ix. NYFS shall defend and indemnify the Municipality from any and all claims or causes of actions brought against the Municipality of any matter arising out of this Agreement or the services provided pursuant to this Agreement; and,
- x. Without the written approval of the Municipality, NYFS will not enter into any agreement with any other municipality which differs from the terms and conditions of this Agreement.
- g. <u>Term</u>. The term of this agreement will be through December 31, 2023. Unless either party gives at least 6 months written notice of its intent to cancel this Agreement effective December 31 of the year in which the notice is made, NYFS will continue to provide services to the Municipality if a successor agreement has not been executed prior to the end of the term.

h. (A) Distribution of Assets Upon Dissolution.

If NYFS ceases to operate, the Board of Directors will do one of the following:

- i. Give the assets to one or more non-profit agencies providing similar social services in the northern suburbs of Ramsey County; or,
- ii. Form a new Foundation to fund appropriate social service programming in the northern suburbs of Ramsey County.

The final Distribution of Assets Plan must be approved by the Ramsey County District Court.

(B) <u>Deviation from the Mission</u>.

If the City Council determines that NYFS has materially deviated from its mission (See II. Recitals, A.), the City Council may ask the NYFS Board of Directors to consider dissolving the agency and liquidating the assets. The Board will do one of the following:

- iii. Consider the request and by a majority vote deny it.
- iv. Consider the request and by a majority vote agree to modify the programs to be consistent with the mission.
- v. Consider the request and by a majority vote agree with the request and move to dissolve the agency and liquidate the assets.

Contracted Services

Mental Health Services:

- Shoreview and White Bear Lake Mental Health Clinics licensed mental health staff provide therapy for the emotional health of children, teens, and adults.
- School-Based Mental Health licensed mental health staff provide onsite therapy in the schools for the emotional health of students within Roseville, Mounds View, and White Bear Lake school districts.

Community Service Programs:

- Youth Diversion a coordinated range of services for youth who have committed minor offenses (e.g. shoplifting, chemical/alcohol use, vandalism) to help them focus on positive behavior and prevent recidivism.
- Community Connections This seven-week program helps youth develop social and emotional skills while expanding their horizons and helping them deepen their commitment to their own futures through service, post-secondary education exposure, career exploration, and mentorship.

Non-Contracted Services

Mental Health Services:

• Northeast Educational & Therapeutic Services (NETS) – provides therapy and academic support for youth in grades 6-12 with severe mental illnesses who cannot function in traditional school environments.

Community Service Programs:

 Community Advocate – This program serves people who have been involved with local law enforcement but have needs that cannot be sufficiently addressed by law enforcement alone. This can include: mental health issues, family instability, medical care and other needs. Addressing these underlying issues reduces the need for law enforcement intervention in the future.

CITY OF NORTH OAKS ORDINANCE _____

AN ORDINANCE AMENDING CHAPTER 110 OF THE CITY CODE "TOBACCO REGULATIONS"

THE CITY COUNCIL OF THE CITY OF NORTH OAKS DOES ORDAIN:

Section 1. Section 110.05, paragraph (B) of the City Code is amended to read as follows:

§ 110.05 BASIS FOR DENIAL OF LICENSE.

(B) Grounds for denying issuance or renewal.

(1) The applicant is under the age of 18 <u>21</u> years.

(2) The applicant has been convicted within the past 5 years of any violation of a federal, state, or local law, ordinance, or other regulation relating to tobacco, or tobacco products, or tobacco- related devices.

(3) The applicant has had a license to sell or dispense tobacco, tobacco products, or tobacco- related devices revoked within the 12 months preceding the date of application.

(4) The applicant fails to meet any requirement in this chapter or fails to provide any information required on the application or provides false or misleading information.

(5) The applicant is prohibited by federal, state, or other local law, ordinance, or other regulation, from holding such a license.

Sec. 2. Section 110.06, Paragraph (A) of the City Code is amended to read as follows:

§ 110.06 PROHIBITED SALES.

It shall be a violation of this chapter for any person to sell, offer to sell, or dispense any tobacco, tobacco product, or tobacco-related device:

(A) To any person under the age of 18 <u>21</u> years;

Sec. 3. Section 110.09 of the City Code is amended to add the following paragraphs:

§110.09 RESPONSIBILITY.

(C) All licensees, at their licensed location, shall display a sign in plain view to provide public notice that selling any of these products to any person under the age of 21 is illegal and subject to penalties. The notice shall be placed in a conspicuous location in the licensed establishment and shall be readily visible to any person who is purchasing or attempting to purchase these products. The sign shall provide notice that all persons responsible for selling these products must verify, by means of photographic identification containing the bearer's date of birth, the age of any person under 30 years of age.

(D) Each licensee shall verify, by means of government-issued photographic identification containing the bearer's date of birth, that the purchaser or person attempting to make the purchase is at least 21 years of age. Verification is not required if the purchaser or person attempting to make the purchase is 30 years of age or older. It shall not constitute a defense to a violation of this subdivision that the person appeared to be 30 years of age or older.

Sec. 4. Section 110.10, Paragraphs (B), (C), (D), (E) of the City Code are amended to read as follows:

§110.10 COMPLIANCE CHECKS AND INSPECTIONS.

(B) From time to me, but at least once per year, the city shall conduct compliance checks by engaging, with the written consent of their parents or guardians, minors persons over the age of 15 years at least 17 years of age but less than 18 21 years, who, with the prior written consent of a parent or guardian if the person is under the age of 18, to enter the licensed premises to attempt to purchase or obtain tobacco, tobacco products, or tobacco-related devices.

(C) <u>Minors Persons</u> used for the purpose of compliance checks shall be supervised by city designated law enforcement officers or other designated city personnel.

(D) <u>Minors Persons</u> used for compliance checks shall not be guilty of unlawful possession of tobacco, tobacco products, or tobacco-related devices when the items are obtained as a part of the compliance check.

(E) No minor person used in compliance checks shall attempt to use a false identification misrepresenting the minor's person's age, and all minors persons lawfully

engaged in a compliance check shall answer all questions about the <u>person's</u> minor's age asked by the licensee or the licensee's employee and shall produce any identification, if any exists, for which he or she is asked.

Sec. 5. Section 110.12, Paragraph (F) of the City Code is amended to add subparagraph (3) to read as follows:

§110.12 VIOLATIONS.

(F) Misdemeanor prosecution.

(3) A person under the age of 21 years who purchases or attempts to purchase tobacco, tobacco-related devices, or electronic delivery devices and who uses a driver's license, permit, Minnesota identification card, or any type of false identification to misrepresent the person's age shall only be subject to the alternative penalty in this Chapter and not be subject to misdemeanor prosecution.

Sec. 6. Section 110.99 of the City Code is amended to read as follows:

§ 110.99 PENALTY.

(A) Licensees. Any licensee found to have violated this chapter, or whose employee shall have violated this chapter, shall be charged an administrative fine of $\frac{575}{5}$ \$300 for a first violation of this chapter; $\frac{200}{500}$ for a second violation at the same licensed premise s within a $\frac{2436-month}{2436-month}$ period; and $\frac{5250}{51000}$ for a third and each subsequent violation at the same premises within a $\frac{2436-month}{2436-month}$ period. In addition, after the third violation, the license shall be suspended for not less than 7 days and may be revoked.

(B) *Other persons.* Persons other than minors regulated by division (C) below and licensees found to be in violation of this chapter shall be charged an administrative fee of \$50.

(C) *Minor*. Minors found in unlawful possession of, or who unlawfully purchase or attempt to purchase, tobacco, tobacco products, or tobacco-related devices, shall be referred to the Northwest Youth and Family Services diversion program.

(D) *Misdemeanor*. Nothing in this section shall prohibit the city from seeking prosecution as a misdemeanor for any violation of this chapter in addition to any other penalty which may be imposed.

Sec. 7. This Ordinance will be in full force and effect from and after its passage and publication according to law.
