# City Council Vacancy - Accepting Applications

The City of North Oaks is currently accepting applications for a City Council vacancy as a result of councilmember Shuman submitting his resignation effective 5-15-2024.

This is a great opportunity for individuals that have interest or are planning to run for the City Council in the November election. The individual selected to fill this vacancy will serve until a successor is elected and qualified during the November 2024 election. If you are interested in running during the November election you must file an affidavit of candidacy between July 30, 2024 and August 13, 2024 to be on the ballot.



Application Deadline: Friday, May 24, 2024 at 12:00 p.m.

To apply, submit completed materials:

 in person by placing your materials under the City Hall office door To be considered for the current vacancy, you must submit the following:

• A current resume illustrating applicable skills and experience

• A letter of interest highlighting why you feel you are the best candidate to fill the vacancy

• Proof of the following qualifications:

- Be an eligible voter
- Be at least 21 years old when assuming office

- Have a residence in North Oaks for at least 30 days before taking office.

# Highlights from the May City Council Meeting - 5.9.2024

Highlights from the Thursday, May 9, 2024 City Council Meeting at 7 p.m. include:

- Six Residents were in attendance to speak both in favor and against the proposed pilot license plate reader program.
- Consent agenda items: Summerfest fireworks permit, National Police Week proclamation, licenses for approval, April City Council meeting minutes, City financials, Gambling permit for CommonBond Communities Birdies for Hope event
- Discussed and approved License Plate Reader Pilot program. Only Ramsey County Sherriff's office and prosecuting authorities would have access to this data as tool for investigating criminal activity that has occurred. Metrics to analyze effectiveness after pilot program after 1 year include:
  - # of vehicles intercepted / stolen registered to offenders
  - # of cases solved with assistance of LPR data
  - # of property crime stats from prior year to current year

Next steps: City to work with NOHOA for review of contract before entering into agreement and finalize logistics with NOHOA and North Oaks Company.

- Approved Conditional Use Permit for home height in excess of 35 feet for property, and driveway setback variance at 8 Sherwood Trail.
- Approved Ordinance amending City Code XV, Chapter 151, regarding garage definitions and garage size standards. The maximum size garage allowed before CUP review is required has been increased from 1,500 to 2,500 square feet. Notices will be published in the paper.
- Approved Water meter pits and meter proposal along Centerville Road, which will be used to monitor water use for maintenance and billing purposes.
- Resolution accepting resignation of Councilor John

Shuman and declaring vacancy

- Approved Resolution 1523 to allow North Oaks Company to pave in Red Forest Way Phase 1 and 2. Paving will give North Oaks Company the ability to complete the trail system and remove barriers at Catbird and Black Lake Roads.
- Councilor Reports: Meeting to be scheduled with Ramsey County Sherriff to discuss contract renewal which expires December 2024. Contract renewal discussions will be taking place with Nine north, Comcast and Cities they provide service to. Discussions ongoing with Lake Johanna Fire Department regarding staff retention, and bonding for proposed fire station. Reminder that Summerfest takes place June 1st and there will be a City table to answer questions. Brief update on the information NOHOA/City meeting on 5/6/24 (see below) residents are reminded that long term strategy planning is just looking at sustainability options in future, no decisions were made on what best service our unique community. Council thanked John Shuman for his service to our community as City Councilor and wished him well.

## Special City Council / NOHOA Meeting

Highlights from the Monday, May 6, 2024 Special City Council/NOHOA Meeting at 6 p.m. include:

- Bolton-Menk Engineering firm reviewed Interactive website / GIS Map that is under development. Discussion will be ongoing to determine what layers may be accessible and useful for resident viewing and where the link is displayed.
- Sambatek Engineering firm presented update on the Master Infrastructure Plan and information on value of developing Road Standards
- Discussion on importance of following Storm Water Requirements as Maintenance work is conducted on roads and culverts.
- North Oaks Company provided update on discussions with St. Paul Regional water and new developments on East side of North Oaks.
- Discussion on desire from NOHOA for City to implement a Goose Management plan in effort to improve water quality and use of recreational areas. City to follow up with USDA for potential contract options.
- Residents are encouraged to sign up to be a Ramsey County Block Captain.

## Two More Weeks to Sign Up for Brush Pickup Day - Thursday, May 30th

Thanks to the 23 residents that have already signed up!

The City and NOHOA are co-hosting and coordinating a brush pickup for interested residents. Brush Pickup Day is Thursday, May 30th, 2024. If all the brush is not picked up that day, work will continue the next day. The estimated cost for a dumpster size load of brush (14ft X 7.5ft X 3.5 ft and equals 10 cubic yards) is \$140, but rates vary depending on the amount of brush.



# Save the Date - City Recycling and Shredding Event

The City and NOHOA will be co-hosting the 6th annual Recycling and Paper Shredding event on Saturday, June 22 from 8 a.m. to 12 p.m. at Southpointe Fields, just off Hwy 96 and east of the City Offices. This event is open to North Oaks residents only.



Residents will be able to drop off a wide range of

recyclable items, including lamps, light bulbs, household and automotive batteries, computers, hard drives, TV monitors and other electronics, mattresses, box springs, residential appliances, and ink/toner cartridges. See below for a link to the complete list of what items can be accepted. A paper shredder will again be available; up to four banker-sized boxes per household, please. Clean scrap metal will also be accepted this year (no attached plastic, wood, etc.)

There will be a fee for most items, although automotive batteries, cell phones, tablets, cords, cables, wires and holiday lights will be FREE. Look for the coupon in the North Oaks News or City website that entitles drop off of one item for free; one coupon per household, please. ## **DNR Urges People to Leave Deer**

### **Fawns Alone**

From the MN DNR Daily Digest Bulletin: The Minnesota Department of Natural Resources asks that people avoid disturbing or touching deer fawns, which are born around this time of year.



Most fawns are born in mid-May to mid-June, and fawns do not attempt to evade predators during their first few weeks of life. Instead, they remain still to avoid being seen. During these times, fawns are learning critical survival skills from their mothers but are often left on their own while their mothers forage watchfully nearby.

Be assured deer fawns are likely fine even if they look abandoned or

fragile. Even if the fawn is known to be wounded or abandoned due to car strike or animal attack, do not transport it without talking to a wildlife rehabilitator. Moving a fawn can be detrimental to the animal and increase the risk of disease spread. # May is Arbor Month in Minnesota - Resources for Tree Care in North Oaks

Arbor Month is celebrated in May in Minnesota. This is a great time to focus attention on tree care, particularly in a community with as many trees as North Oaks.

City Forester Mark Rehder is contracted by the City to provide services to the community, including ensuring adherence to regulations, providing guidance to residents, and helping to identify and control invasive species. Mark also oversees the licensure process for any arborists looking to do work in the City.
